Mr. Loehman reported that the Council had approved 76 contracts – employing 254 individuals with disabilities and totaling \$10 million – during the reporting period. He added that the Horizons had directly distributed 58 new contracts for approval, as well as 12 renewal contracts and 3 contracts distributed in cases of immediate or urgent need, in that same period.

AGENDA ITEM 15: DISCUSSION OF RESPONSIBILITIES OF THE COUNCIL FOR PURCHASING FROM PERSONS WITH DISABILITIES TO CALCULATE FAIR MARKET VALUE, INCLUDING FORMULAS AND METHODS

After lengthy discussion where no resolution or cause for action was decided, the Council agreed to continue the discussion of agenda item 15 at the next Council meeting.

AGENDA ITEM 16: DISCUSSION OF THE APPLICATION OF THE STATE USE ACT TO ELECTRIC VEHICLE CHARGING STATIONS

The Council discussed the ways in which the addition of electric vehicle charging stations might be incorporated at safety rest areas across the state under the State Use Act. Council member Hayden noted that, currently, federal law prohibited the installation of those stations because they would be deemed concession.

Mr. Loehman announced that the New Mexico Department of Transportation held a meeting where this topic had been discussed, and the agency seemed unsure about how the stations would be incorporated if that ever became a possibility.

The Council eventually agreed to table the discussion and continue it at a later meeting date.
