#### AGENDA ITEM 7: CENTRAL NONPROFIT AGENCY, MATT LOEHMAN

Mr. Matt Loehman, Horizons of New Mexico (Horizons), announced that October is National Disability Employment Awareness Month.

Mr. Brian Ammerman, Adelante Development Center, announced that Adelante Development Center had discontinued the utilization of 14(c) subminimum wages effective July 1<sup>st</sup>, alongside the implementation of the Healthy Workplace Act. He added that employees making below minimum wage had been converted to minimum wage rates, and that retroactive payments through July 1<sup>st</sup> had been initiated to those individuals.

## AGENDA ITEM 11: CENTRAL NONPROFIT QUARTERLY REPORT, MATT LOEHMAN

Mr. Loehman reported that, for the reporting period reflected in the quarterly report, the Council approved 60 contracts, providing employment opportunities for 305 individuals with disabilities and totaling more than \$4 million. He added that, for the same period, the CNA approved 14 new contracts totaling \$8,000 and seven renewal contracts totaling \$7,000.

# AGENDA ITEM 12: DISCUSSION OF ADDING TEMPORARY EMPLOYMENT SERVICES AS A SUITABLE OR PERMISSIBLE SERVICE

Mr. Loehman introduced representatives from the Galt Foundation and GSG Talent Solutions to Discuss how temporary employment services could be incorporated into the New Mexico State Use Program and the benefits those employment opportunities would provide to New Mexicans with disabilities.

They outlined the following employment opportunities and positions available to individuals with disabilities, should temporary employment services be incorporated into the Program: administrative specialist, customer service representative, data operator, cook, kitchen assistant, server, janitor, grounds maintenance, housekeeping, warehouse services, inventory manager, IT, accountant, HR specialist, attorneys, engineers, health aids, health screeners

Council member Roger Newall joined the meeting at this time, 1:57 p.m.

The council moved take action on agenda items 4 and 5 before moving back to complete agenda item 12. At the completion of agenda item 12, the Council would continue the meeting agenda items in sequence, beginning with agenda item 6.

After discussion about labor ratios and percentages, pay rates, and logistical implementation of temporary employment services within the New Mexico State Use Program, the Council moved back to agenda item 6 for completion of the remainder of the agenda.

Council member Fresquez announced that the Department of Justice had just issued a notice of proposed rule-making for website accessibility requirements pertaining to state and local governments that would give guidance to those governments outlining what they need to do to ensure that their websites are ADA compliant.

Further discussion and action about the inclusion of temporary employment services under the New Mexico State Use Program, possible legislative recommendations, the central nonprofit agency annual report, and discussion about benefit loss to individuals employed within the Program were added as agenda items for future meetings.
